In September 2014, the two countries agreed to build a 'Closer Developmental Partnership' and make this developmental partnership a core component of the Strategic and Cooperative Partnership for Peace and Prosperity.

Indian citizen need to obtain Chinese visa to travel to the People's Republic of China.
