2. Gifts received by Prime Minister from state dignitaries during his foreign tours in the last 3 years with name of the gift, type of the gift.

3. The following is the response of the CPIO:


1. In this connection, this is to state that the Prime Minister presents gifts, as per the laid down norms during his foreign visits. Information sought by you relates to the name and type of the gifts presented during his foreign visits. It is true that the procurement of gifts is being met from budgetary grants but the revelation of the information sought would have unintended effects on the foreign relations and that any critical analysis/scrutiny and comparison between quantum and value of the gifts would be totally undesirable and would defeat the very purpose of generating goodwill between the nations. Disclosure of this information may prejudicially affect India's relations with the concerned foreign State, exemption is therefore, sought under section 8(1) (a) of the RTI act 2005, wherein no such information as may prejudicially affect India's relations with a foreign State need be disclosed.

2. The information sought by the applicant is related to the gifts received by the Prime Minister through his foreign visits. The undersigned is not the custodian of this information. Since this part of the information is being dealt with by Toshakhana Section of the Ministry, this part has been transferred to US (SE), MEA, CPIO, Room
