





I have received an email from AO(Pension.II) dated 21 July seeking NDC in r/o Shri O.P. Bhoja, formerly Consul in this Post.

2. In this connection I would like to inform you that India Audit Office, London had carried out an audit of this Post in July 2006 and as per the consequent Audit report dated 1 August 2006 there are two objections - one pertaining to irregular reimbursement of gardening charges amounting to £2100/- and another pertaining to irregular reimbursement of conveyance charges amounting to £4523/-. The Audit had recommended that in both these cases the Post may seek regularization of expenditure from the Ministry. At the present moment, both these issues are under examination by the Ministry. We are not aware of any decision taken in the matter and have not received any directive if the amounts are to be recovered or regularised. In the circumstances, the Post is unable to issue a clear No Demand Certificate.
