Please refer to your RTI application dated 22.03.2016 received in this Division. Reply to your query (Q.No-5) related to this Division is as under:

- 2. Article 23 of the Chapter of the United Nations states that the Security Council shall consist of fifteen Members of the United Nations. The Republic of China, France, the Union of Soviet Socialist Republics, the United Kingdom of Great Britain and Northern Ireland, and the United States of America shall be permanent members of the Security Council. The General Assembly shall elect ten other Members of the United Nations to be non-permanent members of the Security Council."
- 3. Further article 108 of the Chapter of UN states that "amendments to the present Charter shall come into force for all Members of the United Nations when they have been adopted by a vote of two thirds of the members of the General Assembly and ratified in accordance with their respective constitutional processes by two thirds of the Members of the United Nations, including all the permanent members of the Security Council."
- 4. Article 23 & 108 of the Charter of the UN infers that the composition of the Security Council is prescribed by the UN Charter, according to which certain specified nations have permanent seats. A large number of countries (including Russia) have supported India's candidature for permanent membership of the UN Security Council. However, the question of India's membership of the Security Council would be considered only after an agreement on the nature and extent of expansion of the Council is arrived at in accordance with the provisions of the UN charter which requires approval by 2/3rd of the Members of the United Nations.
- 5.
