
Sir,

Please refer to your RTI application which was received in this Ministry on 23 April 2016 seeking information regarding future implication of listing of Masood Azhar in the UN List of proscribed terrorist and cant India request Interpol to issue a Red Corner notice against him?

2. This is to inform you that **none** of the query raised in your ibid RTI request fall under definition of "information" as stipulated in Section **2(f) of the RTI Act**. Also under the RTI Act, 2005 only that information is provided which exists and is held by the public authority.
