Sir,

Please refer to your RTI application dated 3/6/2016 addressed to RTI cell, Ministry of External Affairs (MEA), New Delhi.

2. The response to the questions raised in your RTI application is as follows:

China disputes the international boundary between India and China. In the Eastern Sector, China claims approximately 90,000 square kilometers of Indian territory in the State of Arunachal Pradesh. Indian territory under the occupation of China in Jammu & Kashmir is approximately 38,000 sq. kms. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Kashmir to China. The fact that Arunachal Pradesh and Jammu & Kashmir are integral and inalienable parts of India has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

In 2003, India and China agreed to each appoint a Special Representative to explore from the political perspective of the overall bilateral relationship the framework for a boundary settlement. An "Agreement on the Political Parameters and Guiding Principles for the Settlement of the India-China Boundary Question" was signed between India and China on April 11, 2005. At present the two Special Representatives are exploring the framework for a settlement covering all sectors of the boundary. There have been nineteen meetings of SRs so far, last one in Beijing on April 20-21, 2016. Both sides are committed to resolving bilateral issues through dialogue and peaceful negotiations and in a fair, reasonable and mutually acceptable manner.

3. If you are aggrieved with this reply, you may file an appeal to Shri Sujit Ghosh, Director (East Asia), & Appellate Authority, Ministry of External Affairs, South Block, New Delhi - 110011, within a month from the date of receipt of this letter.


OFFICE MEMORANDUM
