
Subject: Information sought under Right to Information Act, 2005.

Please refer to your RTI application dated 25.11.2016, received by the undersigned CPIO on 01.12.2016, seeking information regarding total number and percentage of people with disabilities working in the Government.

Furnishing of this information would require culling out the data from scattered records both at Headquarters and Mission (Post) abroad and would result in disproportionate diversion of resources and is thus exempted under the provisions of RTI Act.
