

Dear Sir,

2. The appellant had sought the photocopies of the complete noting portions of the file/files wherein the permission to him for suing the Embassy of Saudi Arabia in India was refused by the Ministry of External Affairs.

3. It is noted that the CPIO had replied to the appellant that: "This information cannot be provided under Section 8 (1) (a) of the RTI Act, 2005 as it would prejudicially affect the relations with Foreign States. Ministry has already provided to you the relevant information on May 04, 2016".

4. The following has been observed on the response of the CPIO:

Ministry has already provided the applicant the relevant information regarding his application to sue the Embassy of Saudi Arabia in New Delhi vide letter no. DIII/465/01/2016 dated May 04, 2016. The information sought cannot be provided as it will affect friendly relations with a Foreign Government in terms of Section 8 (1) (a) of the RTI Act, 2005.

5. The appeal is being disposed off accordingly.
