2. The response to your query in respect of East Asia Division is as follows:

A Loan amount of US\$ 20 million has been sanctioned in August 2012 for the India-Mongolia Joint Information Technology, Education and Outsourcing Centre (IMJIT) Project. So far nothing has been spent by the Mongolian side for that approved loan amount.

A grant of Rs. 13,79,65,000/- has been sanctioned for upgradation and modernization of Rajiv Gandhi School of Production & Art (RGPSA) at Ulaanbaatar, Mongolia.

3. With respect to other countries handled by East Asia Division the reply is NIL.
