
Sir,

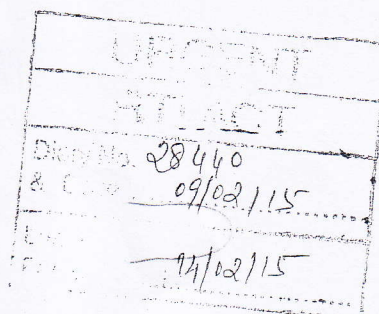
