Exemption is, therefore, sought under section 8(1) (a) RTI act 2005.

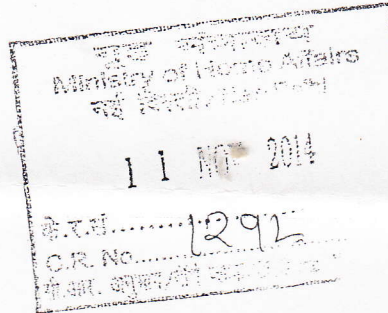
