Kindly refer to your application dated 08/03/2015, wherein you have sought information regarding visits abroad by former PM, Dr. Manmohan Singh and PM Narendra Modi. Your application was forwarded to this Division i.e. West Asia and North Africa Division (WANA Division) of the Ministry of External Affairs by RTI Cell, Ministry of External Affairs, vide OM No. RTI/551/598/2015 dated 16/03/2015.

2. In so far as WANA Division of the Ministry of External Affairs is concerned, the information relating to point 4 and point 8 of your query is as follows:

Point 4- As a founder member of the Non-Aligned Movement, India confirmed its strong commitment to ideals and principles by participating in 15th Summit

Conference of Heads of State or Government of the Non-Aligned Movement, 2009 at Sharm el-Sheikh, Egypt. On the sidelines of NAM Summit, Prime Minister had meetings with leaders of various countries, including the President of the Palestinian National Authority, the Prime Minister of Malaysia, the President of Bosnia Herzegovina, the President of Vietnam, the Prime Minister of Bangladesh, the President of Egypt, the Prime Minister of Pakistan and the President of Sri Lanka. The leaders discussed different aspects of the bilateral relations and aimed at extending mutual co-operation in various sectors. The Conference was an opportunity to meet with a good number of leaders of member nations of Non-Aligned Movement.
