Out of Indian Council for Cultural Relations (ICCR) total sanctioned budget of Rs. 192 crores, a sum of only Rs. 8 crores was earmarked for organising International Day of Yoga (IDY) event by our Missions/Posts abroad.

Missions/Posts are still in the process of finalizing their accounts and hence the actual expenditure will only be known in due course.

With respect to Para 1 regarding "Complete expense spent by GOI on June 21", the Applicant may seek the information from Ministry of AYUSH.

2. In case the Applicant is not satisfied with the above response he may file an appeal with Shri R. Masakui, Director (PD) and Appellate Authority, Room No. 143, 'A' Wing, Shastri Bhawan, New Delhi within a month of the receipt of this letter.


