Please refer to your RTI application dated 20/09/2014 received online by MHA and transferred to RTI Cell, Ministry of External Affairs (MEA) New Delhi on 22 September, 2014.

2. The response to your query in respect of China is as follows:

China disputes the international boundary between India and China. In the Eastern Sector, China claims approximately 90,000 square kilometers of Indian territory in the State of Arunachal Pradesh. Indian territory under the occupation of China in Jammu & Kashmir is approximately 38,000 sq. kms. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Kashmir to China. The fact that Arunachal Pradesh and Jammu & Kashmir are integral and inalienable parts of India has been clearly conveyed to the Chinese side on several occasions, including at the highest level
