Under Section 2(h) of the RTI Act, Indian Missions/Posts abroad are independent and distinct Public Authorities. (In terms of DoPT's O.M no. 10/02/2008-IR dated 24/09/2010), if a person makes an application for information which is scattered with more than one public authority, the applicant should be advised to file separate applications to the public authorities concerned. You are therefore advised to approach the Missions/Posts directly to obtain the required information.
