Logo Competition by India and Indonesia to commemorate 70 years of

Diplomatic Relations

In 2019, India and Indonesia will commemorate 70 years of the establishment of diplomatic relations. Apart from various celebrations to commemorate the occasion, a logo design competition may also be held as a part of the pre-event commemoration activities.

Content of the Contest:

Making of the logo "Celebrating 70 Years of India-Indonesia Diplomatic Relations" (A Logo representing friendly relations between India and Indonesia with designs that can be used for various publications and publicity)

Registration Guidelines:

• Qualification Criteria:

On behalf of an individual, an Indian or an Indonesian national or on behalf of anIndian / Indonesian group / company

• Submit Your entry Before:21 May 2018

Scoring system

All designs will be assessed by a joint committee from India and Indonesia. The committee will select

1) Best design (which will be announced as the official LOGO for the commemoration of 70years of Diplomatic Relations between India and Indonesia)

Winner:

Winner will be announced on the websites of both sides. (Websites of Ministry of Foreign Affairs Republic of Indonesia, Ministry of External Affairs Government of India, Embassy of India in Indonesia, Embassy of Indonesia in India and Consulate Generals of Both Sides)

Appreciation:

Best Design Winner will be awarded return air tickets for the winner plus one between Indonesia and India.

How to Register:

- Each person / company can only register 1 (one) design
- Acceptable design formats should be in the form of .png, .jpg, .jpeg or .pdf, maximum file size below 3 MB, with 300dpi resolution (A4-size printable)
 - * the shortlisted entries will likely be requested to enhance the design format by the assessment committee.
- Brief description and design background created, may be written in Hindi, Bahasa or English languages on the registration form.
 - * This explanation and background will be announced at the time of the announcement of the winning entry.
- Designs may be submitted in 2 (two) versions: Full Colour / FC (no limit on the number of colours or gradations) and Black & White / BW
- The logo data should be original and never been published, both in India and in Indonesia before.
- Designs once submitted and accepted by the committeecannot be withdrawn / cancelled.
- Entries will only be accepted / registered via email

Regarding Copyright and Others:

- 1. The design work to be contested is a work of design that has not been published both inside and outside the country and is not a work that infringes intellectual property rights or trademarks of third parties;
- 2. Design works that are deemed to disturb public order and morality, violate applicable laws and regulations and violate copyright or other rights of third parties, will not be assessed by the committee. If any nomination or winner is found to be in violation of the above applicable laws, the winning status or nomination shall be cancelled forthwith without assigning any reason. In addition, after being announced as the winner, if the design work is found as a plagiarism work, the win will be cancelled. Participants are expected to pay attention to applicable laws, rules and regulations in order not to cause legal problems in the future.
- 3. Please note that, in the event of any claim, dispute and otherwise, it will be entirely the sole responsibility of the participant that is found to be in breach of the terms and the Participant shall release the Foreign Ministries of the two countries from all responsibility and demands of the third party as well as the authorities;
- 4. If the writing of the form is found to be dishonest, although the design work is declared a nominee or declared the winner, the nomination or decision will be cancelled;
- 5. It is possible that the winner will be required to make adjustments or alterations to his or her design work to be finalized. If the design work fails to meet the criteria or requirements for the adjustment process, or the participant does not approve of any adjustment to his or her design work, the win will be cancelled;
- 6. All rights, namely copyright, property rights and user rights of design works declared as winners, shall be entirely owned by the Ministry of External Affairs Government of India and Ministry of Foreign Affairs Republic of Indonesia (including the prevalent rights set forth in the Copyright Acts of India and Indonesia), the Participant shall not exercise any moral right to his work;
- 7. The final design work will be handed over to parties designated by the Ministries of Foreign Affairs and the Embassies of both countries and will be used to commemorate 70years of India -Indonesia diplomatic relations. At that time, in essence, no design changes will be made except changes in size and change from FC to BW;
- 8. The committee shall not provide any personal information (except name and place of work) to a third party, without the consent of the participant;
- 9. The Committee shall not entertain any questions about the selection process.
