Kindly refer to your D.O. Letter No. Z-11025/234/2010.Emig. dated 31.12.2012 regarding minimum referral wages/ salaries for various categories of workers seeking emigration clearance from the offices of Protector of Emigrants.

As per prevalent practice, the Lebanese Government does not issue work permits for persons falling in the category of skilled and professional workers in order to protect the Lebanese market for its own citizens. However, non-skilled workers i.e labourers/industrial workers, cleaners and domestic servants are being recruited as workers without specifying the particular category. The minimum wages for such workers in Lebanon, approved by the Lebanese Ministry of Labour is L.L. 675,000 equivalent to US\$ 450/- at current exchange Regards of Best Wishes for 2013! rates.

This has reference to your message no. Z-11015/234/2010-Emig dated October 11, 2013 regarding the referral minimum wage in Sudan.

- Our requests with the host Government to provide the requisite information have not resulted in any response and therefore the delay occurred in our replying to your query. However, the same is regretted.
- 3. We have checked with some local labour lawyers and have learnt that the Minimum Wage, starting beginning of this year, has been fixed as 425 Sudanese Pound (US\$96 on the official rate of exchange however, on the basis of the fluctuating alternative / market exchange rate, it would be close to US\$65) per month.
- We hope that the above information is usable at your end.
