1.	Name of the post	:	NEST Fellow in the NEST Division of the Ministry of External Affairs Headquarters, New Delhi
2.	Number of vacancies	:	02 (Two)
3.	Period of Consultancy	:	Initially for 01 (one) year The contract can be extended further depending on assessment of performance, mutual willingness and depending on the requirement. The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.
4.	Nature of Duties	:	<ul style="list-style-type: none">• The selected NEST Fellows will be required to work in the New, Emerging & Strategic Technologies [NEST] Division in the Ministry.• Their duties will entail gauging of emerging and strategic technologies and their relevance to India's development, economic growth and national security.• This may include regular monitoring of information relevant for foreign policy formulation, the international normative frameworks being deliberated by countries for negotiation in a multilateral context and providing

		<p>knowledge-based inputs for the same.</p> <ul style="list-style-type: none"> • They will be required to assist in analyses of legal implications of new and emerging technologies and technology-based resources. • They will be required to assist in assessment of demand driven requirements of new emerging and strategic technologies in the country, help identify new emerging technologies of relevance to India and assess potential for collaboration. • They will be required to analyse published material on new emerging and strategic technologies. • They will also be required to attend important meetings, workshops, seminars and conferences relevant to the work of NEST Division, and submit reports on them. • From time to time, they may also be asked to undertake research on specific NEST related issues.
5.	Job Location	: Ministry of External Affairs (South Block, Patiala House, JNB, ISIL Building, SSB, Akbar Bhawan), New Delhi.
6.	Qualifications/ Essential Criteria	<ul style="list-style-type: none"> • The applicant should be an Indian National. • Applicant must be a graduate in Mathematics/ Physics/ Bio-Science/ Computer Science. • The candidates having specialization/ work experience in the field of Artificial Intelligence/Quantum Frontiers/Renewable Energy, Waste to Wealth, Water Space and Deep Ocean Exploration technologies will be given preference • Age Group 30 to 40 years as on the last date of submission of application.

7.	Desirable Criteria	<ul style="list-style-type: none"> • Previous experience of handling issues relating to fields mentioned in para 06 above. • Extra credit will be given for experience of work in a reputed university, think-tank or research organisation in the areas mentioned above and/or foreign policy or international affairs.
8.	Remuneration &Entitlements	<ul style="list-style-type: none"> • The remuneration package will be commensurate with the experience and profile of the selected candidate, subject to a maximum of Rs. 12 lakh per annum and deduction of applicable taxes. The consultancy fees shall be paid in Indian Rupees. The amount of consultancy fee so fixed shall remain unchanged during the term of engagement. • The engagement will be strictly contractual and will not confer any other benefits to the selected candidates. • The consultant shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the regular employees of the Ministry. • No HRA shall be admissible. • The engagement of the Consultant is on full time basis. Normal working hours will be from 0900 to 1730 hrs. Working hours is subject to change from time to time. Saturdays/Sundays will remain closed as weekend off. In exigencies, he/she may be required to work beyond office hours and/or on closed holidays. No extra allowance or remuneration for such work is admissible. He/She shall not accept any other professional appointment, paid or otherwise during the term of engagement with this Ministry. • Paid leave of absence may be allowed to the rate of 1.5 days for each

		<p>completed month of service. Accumulation of leave beyond a calendar year may not be allowed. Leave cannot be claimed as a matter of right. Leave will not be allowed for more than 10 days at a time. Discretion is reserved to the Head of Division to refuse or revoke leave in the public interest. Leave encashment will not be permissible on unspent leave. Unspent leave will lapse on commencement of notice period. No other leave of any kind shall be admissible to him/her. In case he/she remains absent from duty beyond entitled leave, a proportionate deduction from the consolidated fee as applicable will be made.</p> <ul style="list-style-type: none"> • In case the Consultant is required to travel as part of his/her duties, the Ministry will take care of his/her travel, accommodation and per-diem costs, at par with Under Secretary in the Ministry. • The selected person will be required to enter into a contract with the Ministry in a prescribed format w.e.f. from the actual date of engagement as Consultant.
