

ILLEGAL OCCUPATION OF LAND BY CHINA AND PAKISTAN

2757. SHRI Y. S. CHOWDARY:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that Pakistan occupied Kashmir has been illegally occupied by self-governing administration of Pakistan;
- (b) if so, the details thereof;
- (c) whether it is also a fact that China has also illegally acquired Indian territory from Pakistan occupied Kashmir under so called China-Pakistan Boundary Agreement of 1963;
- ,(d) if so, the details thereof; and
- (e) the action taken/being taken by Government in this regard?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS [SHRI V. MURALEEDHARAN]

(a) to (e) Pakistan has been in illegal occupation of approximately 78,000 sq.kms of Indian territory in the Union Territories of Jammu & Kashmir and Ladakh. Under the so-called 'Boundary Agreement' signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq.kms of India territory in Pakistan occupied Jammu & Kashmir and Ladakh to China.



India's consistent and principled position, as also enunciated in the 1994 Parliament resolution adopted unanimously, is that the entire Union Territories of Jammu & Kashmir and Ladakh have been, are and shall be an integral part of India. We have consistently called upon Pakistan to immediately vacate all areas under its illegal and forcible occupation.

- 2. With regard to the information sought in respect of China, under so-called China-Pakistan 'Boundary Agreement' signed in 1963, Pakistan illegally ceded 5,180 sq. kms of Indian Territory in Shaksgam Valley from areas illegally occupied by Pakistan in Union Territory of Ladakh to China. Government of India has never recognized the so-called Pakistan-China 'Boundary Agreement' of 1963 and consistently maintained that it is illegal and invalid. Further, in the Eastern Sector, China claims approximately 90,000 square kilometers of Indian territory in the state of Arunachal Pradesh. Indian territory under occupation of China in the Union Territory of Ladakh is approximately 38,000 square kilometers. India's consistent and principled position is that Arunachal Pradesh and the entire Union Territories of Jammu & Kashmir and Ladakh, have been, are and shall be an integral part of India. This fact has been clearly conveyed to Chinese authorities several occasions. This Ministry has answered several Parliament Questions on this issue which are available in public domain.

It is also stated that under the provisions of RTI Act 2005, a CPIO/ Public Authority is under obligation to provide an applicant only that information which exists in records and that which is held by or under the control of that authority.
