Sir,

Please refer to you RTI application dated 31 January 2019 addressed to RTI Cell, Ministry of External Affairs, New Delhi, received by this Division on 31 January 2019.

2. There is no commonly delineated Line of Actual Control (LAC) in the border areas between India and China. From time to time, on account of differences in the perception of the LAC, situations have arisen on the ground that could have been avoided if we had a common perception of the LAC.

3. Government regularly takes up any transgression along the LAC with the Chinese side through established mechanisms including border personnel meetings, flag meetings, meetings of Working Mechanism for Consultation & Coordination on India-China Border Affairs, as well as through diplomatic channels.

4. The Government consistently maintains that peace and tranquility in the India-China border areas is an important pre-requisite for the smooth development of bilateral relations.

5. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.
