Please refer to your RTI application dated 1/05/2018 addressed to RTI Cell, Ministry of External Affairs and received by this Division on 3/5/2018 with registration no. /MOEAF/R/2018/80.

The information pertaining to the undersigned CPIO is as follows: 2.

China disputes the international boundary between India and China. Indian territory under the occupation of China in Jammu & Kashmir is approximately 38,000 sq. kms. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Kashmir to China. In the Eastern Sector, China claims approximately 90,000 square kilometers of Indian territory in the state of Arunachal Pradesh.

The fact that Jammu & Kashmir and Arunachal Pradesh are an integral and inalienable part of India has been clearly conveyed to the Chinese side on several occasions, including at the highest level.

India and China have appointed a Special Representative (SR) each to explore the framework for a boundary settlement from the political perspective of the overall bilateral relationship. There have been twenty meetings of SRs so far, the last one being in New Delhi on 22 December 2017.

If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.
