महोदय,

कृपया गृह मंत्रालय को संबोधित दिनांक 6.06.2017 के अपने आरटीआई आवेदन का अवलोकन करें जिसे आरटीआई प्रकोष्ठ, विदेश मंत्रालय, नई दिल्ली को स्थानांतरित किया गया था।

चीन के संदर्भ में आपके प्रश्न का उत्तर निम्नानुसार है: 2.

जम्मू और कश्मीर में भारत की भूमि का लगभग 38,000 वर्ग किलोमीटर क्षेत्र चीन के कब्जे में है। इसके इतिरिक्त, 2 मार्च 1963 को चीन तथा पाकिस्तान के बीच हस्ताक्षरित किए गए तथाकथित चीन-पाकिस्तान "सीमा-करार" के तहत पाकिस्तान ने पाक अधिकृत कश्मीर के 5,180 वर्ग किलोमीटर क्षेत्र को अवैध रूप से चीन को दे दिया है।

जम्मू और कश्मीर राज्य भारत का एक अभिन्न एव अटूट हिस्सा है। यह बात उच्चतम स्तरों सहित कई अवसरों पर चीन को सूचित किया गया है।

यदि आप इस उत्तर से संतुष्ट नहीं है, तो आप इस पत्र की प्राप्ति की तिथि से एक माह के भीतर श्री 3. सुजीत घोष, निर्देशक (पूर्व एशिया) एवं अपीलीय प्राधिकारी, विदेश मंत्रालय, साउथ ब्लाक, नई दिल्ली -110011 को अपील दायर कर सकते हैं।



- 2. Query No 1 & 2. Details of Cease Fire Violations (CFVs) and fatal casualties of Army personnel in CFVs along the Line of Control (LC) in J&K under operational control of Army with effect from 03 Jul 2015 to 03 Jul 2017 (last two yrs) are as under:-

Since India-China border has not been formally demarcated, both sides have differing perception of LAC and both sides patrol up to their respective perceptions, due to which temporary transgressions do occur. There is a well established system for exchange of information and projecting any differences through border personnel meetings or flag meetings between the military personnel of the two sides, wherein they are guided by provisions of Border Peace and Tranquility Agreement (1993) and Confidence Building Measures (CBMs) in Military Field (1996) and Protocols on Modalities for the implementation of CBMs in Military Field 2005


